NEW BUSINESS:

<u>Discussion regarding Water St. easement:</u> Property owner, Lassa, began discussion regarding the easement and the concerns the property owners currently have with their garage, yard drainage, and fence. Lassa acknowledged that they will speak with their neighbors about easement concerns.

<u>Consider Updated Locating Service Contract:</u> Damage Prevention Services has been bought by Lazer Utility Locating and they submitted a new three-year contract. After year one the price will increase \$1.25 per locate and \$2.00 per hour for projects.
